This Certificate of TVET Program Registration is hereby granted pursuant to Republic Act No. 7796 creating the Technical Education and Skills Development Authority (TESDA) and in accordance with TESDA Board Resolution 98-03 on the Establishment of the Unified TVET Program Registration and Accreditation System (UTPRAS) dated January 23, 1998 and TESDA Circulars No. 017 and No. 12 Series 2007, Omnibus Amendatory Guidelines on UTPRAS as amended by TESDA Circular No. 45 Series 2007.

Furthermore, the institution must comply with the following:

1. Within a period of one year upon the effectivity of the appropriate promulgated Training Regulations (TRs) and upon due notification from TESDA, an NTR program shall be submitted for re-evaluation and re-registration as WTR in accordance with the prescribed requirements of the TR. A program which is not re-registered within the prescribed period shall be subject to closure proceedings.
2. Graduates of NTR programs shall be subjected to institutional competency assessment based on the assessment tools submitted by the TVIs and approved by TESDA.
3. NTR programs shall be reviewed after the first three (3) batches of the programs based on the employment rates of the graduates which shall not be lower than the regional/sectoral average. NTR programs with employment rates lower than the regional/sectoral average for three (3) consecutive batches shall be subject to closure proceedings.
4. The TESDA Regional/Provincial/District Director shall be informed of any changes in trainer/s and shall subsequently issue a certification as to the new trainers with corresponding certificate TM/AM numbers.

This Certificate of TVET Program Registration shall be subject to revocation should the institution fail to faithfully comply with the rules and regulations governing the offering of TVET programs prescribed by the Authority.

This Certificate shall not extend to any other program or any other branch of the Institution.
